### State Budget/State Aid:

## **STATE AID FY2021**

• In late September, legislative leadership and Governor Whitmer's administration issued a joint announcement that a budget deal had been finalized for the FY22 state budget. On Tuesday, Sept. 21, legislative leaders moved a massive \$50 billion spending plan out of a joint House-Senate conference committee that has shaped the FY22 general government omnibus budget. On Wednesday, Sept. 22, the House and Senate, in separate votes, gave quick approval to the spending plan. The Governor indicated she would sign the budget time for it to take effect for the new fiscal year, which begins October 1.

Libraries can expect the following:

- State Aid will be increasing by \$2M this year

  for a total in FY22 of \$15,067,000
- \$100,000 was added for a Poet Laureate
- \$800,000 was added for a new school/public library partnership pilot program
- \$4.2 M in federal ARPA funding was approved
- Annual Report/State Aid application will open on October 1, 2021 and will be open until Midnight on 2/1/22. Everyone needs to have completed the State Aid form by that time it will be closed and can not be reopened after that period. The application will be using the old census numbers but it is anticipated the State Aid payments will be made using the new figures.

#### **MMLC Administration:**

- Since MMLC is the Fiscal Agents for Friends of Michigan Libraries (FOML), Irene and Eric have attended several FOML meetings in the last two months, including Executive Committee, Budget and Finance Committee and FOML Board meetings.

- Eric set up and attended the MMLC Overdrive Consortium annual meeting. Members were able to reach several agreements as a group.
- Eric attended the Connecting Michigan Task Force Virtual listening tour. Meetings are held quarterly discuss Broadband in Michigan.
- Eric visited Flint Public Library in the temporary location at Courtland Center in Burton. Director Kay Schwartz anticipate closing the Burton location around Thanksgiving and re-opening in the remodeled Downtown Flint building in early Spring.
